1.	I,(Owner), hereby reserve one breeding to ARC Gunnabeabigstar 5386038
	AQHA (4 panel:N/N IMM:N/My) for the Mare, Reg.
	# for the Breeding Fee of \$ 1,000 plus the Chute Fee of \$650 (at contract signing). A
	separate contract is required for each additional embryo produced via ICSI procedure. Foals-R-Us is to be notified of the number of embryos produced as soon as the ICSI procedure is completed. At that time, a contract for each additional embryo produced will be needed. Additional Embryo Fees are as follows:
	Breeding Fee of \$1,000 each and an Office Fee of \$325 each (contract and all fees are due when
	recipient mare has a 45-day positive pregnancy check). FROZEN EMBRYOS WILL BE CHARGED BREED FEE
	FOR THE YEAR THEY ARE UTILIZED AND FOALS-R-US NOTIFIED OF THE YEAR UTILIZED. Breed Fee and
	Office Fee will be due at 45-day positive pregnancy check.

- 3. Owner must attach a copy of the Mare's registration papers to this agreement. Owner agrees to breed the mare specified.
- 4. Mare shall be bred through the use of an Intracytoplasmic sperm injection ("ICSI") procedure into the cytoplasm of a mature oocyte, which physically causes fertilization. Mare Owner may choose to work with any approved facility to have their mare's oocytes injected. Please contact our office for approved facilities.
- 5. Frozen semen will be used for this contract unless fresh semen is available AND requested. Ship semen fees may apply.
- 6. This contract provides for one (1) Breeders's Certificate. If multiple embryos are retrieved from one breeding, it will be the responsibility of the Mare Owner to notify Foals-R-Us of number transferred.
- 7. Stallion Breeding Reports are prepared immediately after the end of breeding season. If not reported by November 15<sup>th</sup>, mare owner will be responsible for all late fees. It is the Mare Owner's responsibility to notify Foals-R-Us when any Frozen Embryos are utilized, and complete contract for the breed fee of the year utilized.
- 8. TO OBTAIN A "BREEDERS CERTIFICATE" YOU MUST NOTIFY FOALS-R-US OF THE BIRTH OF THE FOAL. CERTIFICATE WILL NOT BE ISSUED IF THE ACCOUNT HAS NOT BEEN PAID IN FULL.
- 9. If it should become necessary for Foals-R-Us to retain the services of an attorney to enforce it's rights under the terms of this contract, including but not limited to the collection of any sums due, the Owner will pay Foals-R-Us all expenses and costs, including reasonable and necessary attorney's fees incurred by Foals-R-Us in enforcing this contract.
- 10. Any dispute related to this contract will be governed by the laws of the State of Texas and venue of any dispute arising from this Contract shall be in Grayson County, Texas.
- 11. This Contract is non-transferable nor assignable without prior written consent from Foals-R-Us.
